**ITEM 3: Dana Point Harbor Revitalization Project**

**Greg Siminoff** from the Dana Point Harbor Partners provided an update on their community outreach efforts for the Harbor Revitalization Project.

**PUBLIC COMMENTS**

**Jim Miller** (Dana Point, Coffee Importers) spoke in favor of the Revitalization project, stating that the Harbor merchants are excited and can't wait to get started.

**John Hicks** (Laguna Niguel, Harbor Grill) spoke in favor of the project as a longtime merchant, expressing that the Dana Point Harbor Partners have been great at communicating with the merchants.

**Don Hansen** (Dana Point) spoke in favor of the project and expressed his hope that this will expedite parking solutions.

**Donna Kalez** (San Clemente, Dana Wharf Sport Fishing) spoke in favor of the project.

**Hoiyin Ip** (Dana Point) thanked the Dana Point Harbor Partners for their workshop, and suggested native plants, biodegradable single-use food and drink containers, and EV parking be used at the Harbor.
